UNITED NATIONS AND EUROPE DRIVE NEO-COMMUNISM

Among the factors that have contributed to the proliferation of international organizations are economic globalization, the rise of Western wealth and, above all, the emergence of the macro-State.

In turn, international organizations, such as the United Nations, the Council of Europe and the European Union, drive the growth of macro-states, as well as the diversion of public money to them and their international bodies.

International organizations are power structures and as such tend to attract people who believe that societies should be managed in a centralized manner, limiting individual freedoms for the benefit of the majority, i.e., with ideas close to communism.

The United Nations has 37,000 employees and the European Union has 32,000 employees. These gigantic human structures have to justify their existence, so they are continually creating projects and standards. The worst thing about this dynamic is that much of what is useful is censored or modified by neo-communist interests and, to a lesser extent, by bribes to technicians and politicians, so most of the work is wasted.

The United Nations Agenda 2030, published in 2015, sets a milestone in the push for totalitarianism and the macro-State by the UN, the European Union and the Council of Europe, which are the three main transnational organizations of the West.

The most noteworthy aspect of the 2030 Agenda is the Sustainable Development Goals (SDGs) to be achieved by 2030. There are 17 goals and only the last one refers to the business sector and civil society, so it can be said that the 2030 Agenda seeks to increase institutional power directly in the first 16 goals and indirectly in the last goal. Moreover, given that it aims to mobilize unprecedented economic resources, it can also be said that it seeks greater interventionism in the business sector

and in societies as a whole, causing massive impoverishment in the West, which is the major financier of UN projects.

In the last goal of the 2030 Agenda, the UN intends for the business sector and civil society to form partnerships to share their "knowledge, technical capacity, technology and financial resources to support the achievement of the Sustainable Development Goals in all countries."

The United Nations pretends that all humanity should contribute to transforming the world in order to increase the power of the UN and national institutional metamafias, making it a decadent pretension in itself and incompatible with human progress. For this reason, the Agenda 2030 is also known as the Agenda 1984, in reference to George Orwell's 1984, whose most popular idea is the Big Brother who watches over everything and, more recently, the Ministry of Truth that imposes the falsehood of the official version has become popular.

In 2020, the so-called coronavirus pandemic has significantly boosted the Agenda 2030 and totalitarianism.

We have seen how international and national institutions have created an official version of the pandemic. This version has disregarded the scientific method. Politicians and the institutionalized media have criticized scientists who have questioned the official version. Scientists and physicians who have opposed the official version and official medical treatments have often been retaliated against.

We can conclude that the coronavirus has put an end to science when it is contrary to the interests of the institutional metamafia. Thus, health becomes in the hands of totalitarian political interests.

Given the side effects of the experimental COVID-19 vaccines, probably more severe and deadly than those of COVID-19 itself, it has even been said in the networks that the pandemic was created to vaccinate the population.

Few governments have opposed the version and guidelines of the United Nations World Health Organization. The situation has been described as a medical dictatorship.

The United Nations, creator of the human right to freedom of expression, was already in 2018 considering how to restrict freedom of expression on social networks. On everything related to the pandemic

and experimental vaccines, absolute censorship has been imposed. Since most major media outlets do not confront the institutional metamafia, for fear of reprisals or because they get institutional advertising and other benefits, restricting freedom of expression on social networks is tantamount to installing the Orwellian Ministry of Truth.

Also in 2018, the United Nations and the European Union, in a coordinated manner, published a report on corruption for each country or region. It is conceivable that by making it known that all countries are corrupt, to a greater or lesser extent, they intended to make people accept corruption of public authorities as inevitable.

Both the United Nations and the European Union, as we have reported in other documents, have taken advantage of the situation to considerably increase their income, impoverishing the entire population, and to increase the totalitarianism that centralized political decisions entail, due to their mandatory nature, even when they are simple recommendations.

The Council of Europe is seeking to eliminate judicial control of involuntary placement in psychiatric institutions, even though the United Nations has established that it violates human rights.

Governments have also taken advantage of this to reduce wealth production and increase subsidies, greatly increasing economic interventionism and economic dependence on public money, both from individuals and companies.

Logically, the increase in public debt means an impoverishment for years or decades of the entire population, which is one of the main objectives of Western and international institutions.

To finish describing what neocommunism is, it is worth adding the institutional dominance over the economy achieved in the 20th century and which the pandemic has boosted.

For many decades, the main annual economic event has always been the State Budget. Therefore, all Western economies have a high degree of centralized planning, which is the main economic characteristic of communism and makes it a decadent system.

In addition to this conjunctural (annual) neocommunism, although

repeated year after year, the main structural economic factors continue to be economic laws such as mercantile and labor laws, which further promote the domination of institutions. The same institutional dominance is driven by the laws for the social sector of associations and foundations.

In our Manifesto on the New World Order (NWO) and the New European Order (NOE) we already said:

At the World Economic Forum 2019 Professors Petroulakis (ECB) and Andrews (OECD) stated that "Europe's productivity problem is partly due to the rise of zombie firms crowding out growth opportunities for others." It is telling that two economists from these two international bodies assume that neointerventionism is destroying the economy.

The zombified economy is constantly destroying jobs through layoffs and making it difficult to create new jobs.

The economic agencies of the UN and the European Union are pushing for the total zombification of the economy, as in communism, to reduce wealth in the West and for the majority of the population not to work, having only basic needs covered by public subsidies.

As this economic dominance increases, so does psychopathy and the difficulty of business operations, forcing companies to pressure their workers, creating an inhumane and unsustainable work environment.

Neocommunism has numerous totalitarian forms, including democracies, but it always leads to decadence, turning the political system and institutions into the problem of all societies.

All political options are neocommunist because they support the macro-State, as an instrument to enrich themselves through corruption, which is the main individual objective of politicians.

Each new public activity or service, national or international, means more impoverishment of the population, more corruption, more totalitarianism and more decadence. The only possible solution is to create a new system, possibly without public institutions, that will usher in a post-democratic Era.

In 2022, we can affirm that institutional metamafia has killed science, individual freedom and the free market, driving the majority of the
