THIS IS HOW THE WEST HAS BEEN DAMNING ITSELF

With some precedent, in 2003 the world's leaders adopted the United Nations Convention against Corruption.

Its preamble begins with the following text:

Corruption is an insidious plague that has a wide range of corrosive consequences for society. It undermines democracy and the rule of law, gives rise to human rights violations, distorts markets, undermines the quality of life, and allows organised crime, terrorism and other threats to human security to flourish. This malign phenomenon is found in all countries - large and small, rich and poor—

In this way, the UN and governments all over the world warned us that these are corrupt, that they had created authoritarian and totalitarian democracies, controlling the rule of law, violating human rights, replacing the market economy with the ECONOMY OF CORRUPTION, creating a decadence that makes the majority live worse every day, encouraging organised crime especially in the institutions themselves to create insecurity, impotence and submission.

Nobody reacted to this statement about the reality of the time and about what was going to happen in the future.

According to CaixaBank Research with data from Bloomberg, in the 1990s sovereign (public) debt had an average maturity of 25 years and has risen to 54 years between 2006 and 2015, with Ireland and the decadent Belgium (see our article 'The 6 decadents', influential in the EU and the ECB) standing out with 100-year bonds.

Then came the Great International Crisis of 2008 and in 2010 the report 'PROJECT EUROPE 2030. Challenges and Opportunities', produced by the "Reflection Group on the Future of the EU in 2030" for the European Council (governments of the Member States of the European Union), which states that: "For the first time in recent European history, fears are widespread that today's children will enjoy a lower standard of living than their parents" generation'.

In the absence of reaction, in 2015 governments at the UN approved the 2030 Agenda, which did create growing popular opposition, especially since 2020.

In the absence of reaction, in 2017 governments appointed the two genocidal and current UN Secretary General and WHO Director General.

In 2018, the United Nations published the level of corruption as a percentage of GDP by region and worldwide, while the European Union did the same by country (Spain 8% of GDP, according to the Bank of Spain more than 13.71% in extortion of companies alone).

In the same year, the United Nations and the European Union also synchronize to start talking about private disinformation, excluding institutional disinformation, excluding institutional disinformation.

In May of the same year, two UN bodies, the World Bank and the WHO, created the Global Preparedness Monitoring Board Secretariat. There was also no public or popular reaction.

In the absence of a reaction, the current genocidal presidents of the European Parliament and the European Commission (former German minister accused of corruption and saved by the decadent Angela Merkel) were appointed in 2019.

In 2020, politicians took advantage of the announced pandemic to invent measures of genocide, impoverishment, submission and social control such as confinement, the use of respirators that Italy spared us, masks (muzzles), injections.

Governments ask the United Nations and the European Union to put pressure on their own governments to eliminate freedom of expression, including freedom of information (press), freedom of movement, pushing for the sequestering of the entire population, and freedom of pharmaceutical treatments. It is little understood that the European Union and the United Nations are intergovernmental organizations, i.e., created and run by the governments of the Member States.

The medieval system of governance: nobility/Church created the bureaucracy that later replaced it at the top of power, giving way to today's manipulatively named liberal democracies. Today, international organizations are replacing, in part, the governments that created them.

In the face of a strong, but insufficient, scientific, medical and popular reaction, in 2022 governments renewed the two aforementioned UN posts. The same was done in the European Union in 2024.

On April 2, 2023, the United Nations published a news item with the following headline: "25% of the world's public spending is lost in corruption". Three months later, Spaniards vote for those who impoverish them by stealing their money and their life project. This percentage raises the figures published in 2018 by the UN itself and by the European Union, it is the price of the lack of reaction.

One year later, the same thieves are voted again, in Spain and in the rest of the countries, so that, as in the UN, the governments and the European Parliament, the presidents of the Parliament and the Commission are renewed again: more corruption, totalitarianism and decadence.

In December 2024, the US Congressional report reported that no action against the 2020 pandemic had scientific backing, nor had the COVID-19 vaccines that have caused serious adverse reactions in more than one million Americans, with more than ten thousand deaths documented, and there has been no reaction.

In the European Union, it is worth recalling the European Green Deal, Next Generation EU, the Draghi Report (unprecedented indebtedness to increase centralised economic planning, military business, the rise and concentration of power, and the massive impoverishment of the population); automated censorship, increased institutional repression, total control by eliminating privacy, digital currencies for total control of the economy and the gradual implementation of communism (nationalisation of the financial system, then of companies and finally of citizens), tokenisation to increase GDP and public debt, creating a new scam market, the results of the elections in Romania are annulled because non-globalists win and are prevented from running again, in France Le Pen is condemned and prevented from running again because of the high probability that she would win the elections (In the European Union the decadent democracy is maintained, but the results are

annulled when they do not interest the institutional metamafia).... . And all with the consent of the majority, conveniently misinformed and manipulated by politicians, traditional and new informers, as well as by the masses themselves, asleep and awake (according to them) who continue to spread the decadence.

As is now said in the face of catastrophic evidence: 'Enjoy what you voted for' (decadence).

The lack of reaction against information about corruption makes the institutional meta-mafia, national and international, increase its corruption and contempt for the governed, as well as mass impoverishment, authoritarianism, totalitarianism, social control and decadence.

There can be no solution as long as people continue to vote for the political parties that have governed, the politicians of decadence.
